## 13/131 APOLOGIES FOR ABSENCE & DECLARATIONS OF INTERESTS

There were apologies from Councillor Wadsworth. There were no declarations of interest.

#### 13/132 MINUTES OF THE MEETINGS HELD ON 17 SEPTEMBER 2013

Minutes previously circulated. These were accepted and signed as a correct record.

## 13/133 PUBLIC FORUM

Concern was expressed regarding the matter of a residents parking scheme. The Clerk read the response from NYCC Highways saying that Hambleton View did not meet the criteria for a scheme. The problems of inappropriate parking and damage to the roadway by visitors and deliveries to the surgery was highlighted by two residents and it was agreed the Clerk write to NYCC Highways highlighting these concerns. It was also confirmed that no planning application had been made by the surgery at this time for a new surgery / health centre.

## 13/134 CLERK'S REPORT AND MATTERS ARISING FROM THE MINUTES

- a. There was a further report of a new caravan opposite the Station Inn and two people had been seen carrying a cooking pot to it. Clerk to report to Hambleton DC.
- b. As no owner could be established for the land at Warehills Bridge where rubble had been fly tipped the Council would not pursue the matter further.
- c. A quote for the new allotment scheme fencing had been received and about £3,000 would be required. It was agreed the Clerk contact Hambleton DC and see if any s106 monies could be released for the project.
- d. Unfortunately the overgrown hedge reported last month was not Oak Dean. The correct property would be identified and reported to NYCC Highways.
- e. The Sports & Recreation Committee had informed Hambleton DC that their car park was not a suitable location for a recycling centre.
- f. NYCC Highways had replied that Hambleton View did not meet the criteria for a residents parking scheme.
- g. PCSO Kim Laws had visited the village and observed the problem of parking on pavements. She suggested signs be put up by the village hall in the first instance.
- h. A copy of the housing needs survey form had been received from Hambleton DC. It was agreed that a survey was not required for at least a couple of years.
- i. The millstone had now been further damaged by the electric company. It was agreed the Clerk obtain prices for a suitable replacement in brick.
- j. The Sports & Recreation Committee had informed Hambleton DC that their car park was not a suitable location for a recycling centre.
- k. The broken manhole cover outside White House Farm had been reported to NYCC Highways.
