- 2. Minutes the minutes of the Parish meeting held on 6 November 2007 were agreed as correct and signed by Mr Spark.
- 3. Matters Arising
 - a) Presentation to Mr Wilson White Lordship of the Manor of Tollerton. Mrs Jackson made a short speech advising those present that the Council had received a letter from Captain Brian Harrison-Barry, who resides mainly in the USA, that he would like to relinquish the title of Lordship of the Manor of Tollerton. Captain Harrison has know Mr White for some years and felt that Mr White would be the most suitable recipient of the title. Accordingly, Captain Harrison had arranged for the title to be legally transferred and Mrs Jackson presented the framed original document to Mr White. It is hoped that the local press will be interested in this story.
 - b) Rabbit Fencing at the Playing Field still only one tender has been received and the Council felt that it was not appropriate to proceed with out a second quotation. Mr Spark is to chase the Easingwold contractor who viewed the site.
 - c) Playground Maintenance Tender only one quotation had been received from Ludus Leisure, a Tollerton based business. Mrs Wadsworth declared an interest. The tender agreed to carry out all the remedial repair work as highlighted in the September RoSPA report free of charge and to carry out biweekly inspections free of charge. If any future work is required costings will be submitted to the Council for consideration. The Council expressed gratitude and gratefully accepted the generous offer.

Mrs Johnson asked about progress in relation to the Parish Plan. Mr Brown advised that despite a large amount of work having been carried out a plan had not been formulated and YRCC had recalled the unspent funding. Mrs Jackson advised that progress had essentially been halted by the uncertainty surrounding the affordable housing proposal. Mrs Johnson advised that Lisa Wilson at HDC could help with the development of a new plan and advise on funds available. She felt it was the duty of the Council to convene a meeting to request volunteers (Mrs Johnson advised that she was unable to volunteer although had done so previously). Mr Spark advised that this had been done a couple of years ago and that few people had come forward. It cannot be managed by the Council. Recommencing the development of a Parish Plan will be looked at in the near future.
