

**MINUTES OF A MEETING OF
TOLLERTON PARISH COUNCIL**

Held in the Village Memorial Hall on 5 February 2008 at 7.30pm

Present: Councillors: Mr Spark (Chairman), Mrs Wadsworth, Mr Simpson, Mr Brown, Mrs McAlpine and Mrs Rogers (Clerk).
2 members of the public and Cllr Campbell

1. Apologies received from Sue Jackson.
2. Minutes – the minutes of the Parish meeting held on 8 January 2008 were, subject to a minor terminology amendment, agreed as correct. Mr Spark is to sign an amended copy.
3. Matters Arising
 - a) Rabbit Fencing at the Playing Field – no further quotations have been forthcoming despite the best efforts of the Council. It was therefore unanimously agreed that the estimate of £2,489 +vat from Wayside Lewis be accepted. Clerk is to write accordingly.
 - b) Parish Plan – Mr Brown had sought guidance from Jo Buffey at the Yorkshire Rural Community Council as to the best way forward. The Parish Council must not be directly involved in the development of the plan, however, a vote of confidence is needed from the community for a plan to be successfully evolved. Ideally a 50/60% response rate to any questionnaire is needed with at least 6 people forming the core development committee. The Council thought that representation across the community was needed e.g. from playgroup parents through to attendees of the monthly soup lunch. Having a plan in place will benefit the community in future funding applications that may be made. Many other local parishes now have plans in place and some funding sources will only accept applications for grants where a need has been identified in a parish plan. It was agreed that the opinion of the community and strength of support would be sought and Mr Brown is to formulate a letter / questionnaire to be circulated to villagers. Mr Spark felt that the AGM in May would provide a good opportunity for communication.
 - c) Grass Cutting – two tenders had been received: £912 +vat from G Marston of Wetherby and £1,461 from Dotwill Garden Services (the current village based contractor). Despite the local connection of the current contractor the Council felt that the £549 price disparity dictated that the tender from G Marston be accepted. Clerk is to send out contract.
 - d) Affordable Housing – The Council was most concerned that planning permission had been granted to Accent for the development of the affordable housing without an approved s.106 agreement in place. The Council had stressed from the outset that it wished to be involved with the planning process to ensure that the wishes of the community would be taken into account specifically in regard to ensuring a local connection criteria would be applied for future occupants of the affordable houses. This was promised by Fiona Coleman (the then rural housing enabler) to the community a number of times and specifically at the open public meeting in January 2007. The community was also promised it would be consulted on the plans for the development, however, an unapproved plan was submitted and the objections of the Parish Council were completely disregarded. In addition, it had been hoped that a planning gain could benefit the community in terms of traffic calming measures associated with the development although it would appear that this opportunity has now been missed. Mr Simpson advised that he had attended a public meeting on January 29th at which Ms Madden (the current rural housing enabler) claimed not to have had any communication from the Council in regard to the s.106 request. Also at this meeting it would appear that only 6 names have been put forward for the 12 houses being built – another concern that had been raised by the Parish Council at the January 2007 open meeting. Councillors felt that local residents in need should be encouraged to register their names. Cllr Campbell advised that there are changes proposed to implement a point scoring system for potential occupants of affordable housing as under current government legislation occupancy cannot be limited to a specific group. The point scoring system should be a sufficient method of control if it is seen by the applicants to be fair and is correctly applied. That said, the Council still feel that the whole process has been a 'fait accompli' and that none of the local concerns have been taken into account.

Cllr Campbell advised that Anne McIntosh had wanted to arrange a local meeting regarding the Post Office proposals, however, the Post Office was not prepared to visit local areas and had arranged meetings in local towns. Mr Lancaster apparently feels that the reduced facilities that are to remain under contract to Poppleton Post Office will be adequate.

9. Any Other Business

a) Following an inspection of the play equipment the maintenance contractor has recommended that the area under the roundabout need building up and recommends that a grass mat be installed at a cost of £39.50+vat. Approved.

b) Bus stop opposite the Church – Mrs McAlpine attended a site meeting as the owners of the house behind the stop are requesting that it be re-located further towards the Newton Road end of the village.

Originally the owners simply wanted the school bus stop moving on the grounds of health and safety, however, they now want to put a driveway on the front of their property so are asking for the stop to be re-located altogether.

Mrs McAlpine advised at the site meeting that there had been no issues with the site previously and that to move the stop further away from the village may disadvantage many villagers and encourage them to drive to the bus stop. The matter is being looked into by Hambleton District Council.

Mrs McAlpine reiterated Mr Brown's concerns raised at the January meeting regarding the level of dog mess in the village. Clerk is to report the situation to Hambleton District Council.

Mr Russon requested that Hambleton District Council be chased regarding the change of the bus stop posts to wooden ones, as previously agreed, as more befitting a conservation area. Clerk is to write on this and also advise that the bus stop sign on the post outside the St Michael's Church is missing.
