- a. Councillor Brown had reported that NYCC Highways had carried out works relating to the flooding on South Back Lane.
- b. The Land Registry website had not allowed the BMX site on Sidings Lane to be identified. Clerk to write to neighbouring landowners to try and identify the owner.
- c. A site meeting would be arranged with Jane Charlton of NYCC Highways and Councillor Sowray would attend. Clerk to write to NYCC.
