1. APOLOGIES

There were apologies from Councillors Mark Brown and Gerry Robins.

2. MINUTES OF THE MEETING HELD ON 1 DECEMBER 2009

3. MATTERS ARISING FROM THE MINUTES

- 3.1 Pot holes were still present on Sykes Lane. Clerk to chase up NYCC Highways when the snow has cleared.

- 3.3 The results of the traffic survey had still not been received. Clerk to chase up.
- 3.4 No reply had been received from Mrs Hardy regarding the fallen tree.
