MINUTES OF THE MEETING HELD IN TOLLERTON MEMORIAL HALL, TOLLERTON ON TUESDAY 7 July 2016 at 7.30PM

33 members of the public were present.

The Chairman opened the meeting and as many members of the public had attended the meeting to listen to the presentation of Daniel Gath it was agreed to bring this Agenda matter forward and have the presentation before at start of the meeting.

16/05 Presentation by Mr Daniel Gath regarding new housing development to incorporate a new Doctors Surgery

Daniel Gath thanked the Parish Council for allowing the presentation to take place. Mr Gath advised this presentation is to get the thoughts initially of the Parish Council to the development, there will be a further public consultation to get the views of the village. The surgery has a window of opportunity as the NHS have granted funding for a new surgery. The current surgery as it now stands is border lining to meet the latest regulations of the NHS. Dr. Mike Potrykus addressed the Parish Council stating he had practised here for 30 years and part of his job is not just about treating patients but is about health care planning for the future it is obvious now the current surgery is not fit for purpose. In January 2015 an application was made to NHS England Primary Care Infrastucture Fund at the behest of the prime minster at the time 36000 GP's in the country submitted a business plan and the NHS approved Tollertons plan in principle. The plan was submitted as a surgery fit for purpose and with the involvement of a developer seen as good value for money by the NHS Tollerton is 1 of 3 administered by the Commissioning Group being given funding based on certain conditions. Dr Potrykus feels this is the last opportunity Tollerton will have to have a health care centre in Tollerton. If the plan doesn't go ahead then he feels the scenario will be to lose the current surrgery and Parishioners will either have to joint Easingwold or Shipton. Easingwold is 58% over subscribed in terms of patients and will not take on patients from villages. In a nutshell if this project doesn't go ahead the likelihood is Tollerton will not have a medical facility in the village. This is an opportunity the NHS England are providing two thirds of the funding, if the current medical premises are sold and restored to two domestic bungalows this will provide additional funding and Tollerton will have the opportunity of a state of the art medical Dr Potrykus advised he will be retiring soon and we to look at the future generations and retain a medical centre in Tollerton.

There is a timeframe to work to by the NHS however there may be some slippage from over projects.

Some Parishioners wished to ask questions and raised concerns over the new houses to be built however it was agreed there will be a public consultation in the village within 3 to 4 weeks, the whole village will be a mail drop when concerns can be raised prior to submission of the planning application which has to be made within the next 3 months. The public consultation with the village will be held in the village hall.

PUBLIC FORUM

A Parishioner expressed concern at pedestrians crossing Station Bridge and asked the Parish Council if a footpath could be installed when Network Rail close the bridge for improvement works. The Council advised this is raised at most of our meetings and County Cllr Sowray was in attendance at our last meeting who suggested we try to get traffic lights on the bridge he was going to take the matter up with North Yorkshire County Council on our behalf. It was agreed to invite County Cllr Sowray to our next meeting to see if he can provide an update for us.

A Parishioner advised she would like to meet with either the full Council or a Parish Councillor to discuss the allotments on Sykes Lane as she would like to take two allotments and also the area we are intending to turn into an orchard. The Parishioner advised we have a vermin problem and there has been some fly tipping on this land. If the Parish Council agreed she would like to rent the area that floods, she will clear it and resolve the vermin problem and fence this area. Cllr Hope agreed to meet at the site on Saturday morning.

A Parishioner, Becky Hardy was asked about the dog dispensers and offered to assist with filling the dispenser with bags if this helped the Council. It was agreed to pilot the dispenser in **South Back Lane** outside Becky Hardy's house and take her up on this offer.
