Public Forum

An opportunity for members of the public to comment on Agenda items.

1. Community Housing

Amanda Madden Hambleton DC advised she had come along to the meeting to advise the Parish Council as a matter of courtesy Hambleton DC are looking at a piece of land for affordable housing in Tollerton. Following a needs survey carried out in 2015 the survey has identified a need for 21 Affordable Homes. 11 identified requiring a 3 bedroom property, on their annual earnings they would have to equate to 9.2 times their annual salary borrowing. The site currently being looked at by HDC is for 100% affordable for local people. When asked by the Parish Council to identify the site she advised is was off Alne Road. This site is outside the Parish Boundary and this was pointed out to Amanda. The Parish Council had not been informed of the survey carried out in 2015 and asked for a copy to be provided as soon as possible. Council felt there is already a large number of affordable housing in Tollerton, whereas other villages do not see to have the same quantity. There are no school facilities in Tollerton and the majority of people needing these houses will probably have young children. Amanda Madden advised there is going to be a public meeting on the 21st November to identify the site and get peoples comments. Amanda Madden promised to e-mail to us the checks carried out for the affordable houses owned by Accent Homes as it was felt some of the occupants are people with no local connection to Tollerton.
