County Cllr Sowray advised he has got some grant funding available but would need to know what the funding is used for and is not available for works that have already commenced on a project.

1. Attendance by Sam Hutchinson – Community Mapping Officer Office of the Police & Crime Commissioner for North Yorkshire

Mr Hutchinson advised he is currently working at the Community Mapping Office and would like to find out what groups and what facilities there are in the village and contacts to keep local people informed of crimes within the area. He is Trying to find what channels of organisations there are from the local area so that topics that may concern the village can be circulated with information to circulate around the village. Information was passed on to Sam.

It was agreed to bring 8.1 on the Agenda forward to discuss now as some members of the public forum were in attendance at the meeting to hear the Council's views on the matter.

If the Parish Council does know of anybody that might be struggling then there is money available without having to go through means tested.
