**Public Forum**

**Christmas lights** was brought forward into the public forum – A Parishioner raised concern that not every household in the village was aware of the survey and had opportunity to comment, Council advised that 250 leaflets were posted through letter boxes, leaflets were left in the shop and there was the on-line survey, notice in the Parish Notice Board nothing further could be done. It was agreed to Agenda this matter for the next meeting and further estimates are awaited for the electrical supply to the green. Council confirmed its agreement to cover the cost of the insurance and the PAT tests.

**7. Election 28 November 2019**

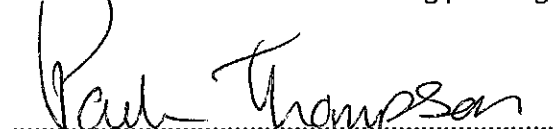
Notification was received from Hambleton District Council Elections Office advising there will be no election as Sue Brookes has been elected onto the Parish Council.

It was **resolved** to accept the quote from Gary Marston to clear the footpath in the sum of £350.00 plus VAT.

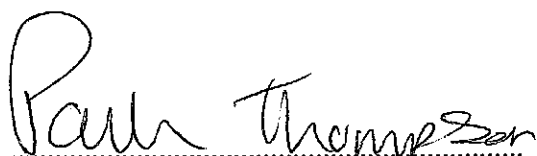
