Public Forum

A Parishioner asked if the Parish Council would approve a granted for some funding towards employing an expert witness if the refusal of planning permission were appealed for the Anaerobic Digester. The Parish Council was advised that the fact it was recommended by the officers for refusal NYCC are in a strong position to defend the application it is does come to appeal.

5. NYCC matters

Cllr Sowray advised that the County Council Executive have agreed in principle Parish Councils may purchase the "slow down" activated signs. The signs have to purchased by an approved supplier and NYCC have to give approval to the location. NYCC are just work on a Contract which should be finalised in the next 2 months. The signs have to be moved around and cannot be in one location permanently.

No matters were discussed.


7. Village Litter Pick

19/00229/REM application for the approval of reserved matters for access, appearance, materials, scale, landscaping and layout outline approval land of Forge Lane, Tollerton. Council had no objections.

19/00186/CAT application to fell 7 trees and carry out works to 8 trees in a conservation area at Finsbury House, Main Street, Tollerton. Council had no objection to the works in principle but would object to the number of trees to be felled and would prefer the mature trees to be trimmed which would allow more light to the property.

19/00193/FUL full planning permission for the creation of 5 no residential dwellings on field 2211 South Back Lane, Tollerton. Council objects to this application South Back Lane is a single track road which has poor access, it is a rear access to many of the properties on Front Street and cannot cope with extra vehicles. Council wished to see refused highway grounds, width of the road. Our Parish Plan people stated no further development.

19/00258/FUL single storey pitched roof extension with oak framed windows at The Croft, Newton Road, Tollerton Council wished to see approved.

19/00256/CAT works to trees in a conservation area North Riding House, Main Street, Tollerton Council had no objections and wished to see approved.
