1. Apologies

5. Matters arising from the Minutes of the last meeting and Clerks report.

- 5.1 Replacement Trees at Old Way & planting of Trees in the village –It was agreed to defer this matter to the next meeting, the matter is ongoing as it is now the season to plant trees.

Any footpath or such installation would apparently be very costly and not high on their list of priorities.

The junction beside the public house is a priority. If Paul Crosby does come to the village it was also felt a discussion about Wharehills Lane junction would also be useful.
