It was agreed to bring Agenda item 7 forward **The trees on Ings View** – Cllr Ferris had visited the site and produced photographs of the overgrown trees, there is a high probability there is root damage as a property in near proximity has lifted flag stones. There was also concern that the trees could come down with high winds causing damage. It was agreed to see if planning permission is required if so the Clerk will make an application and obtain a quote for their removal. Clerk will update Council regarding the planning application.

It was agreed to bring Agenda Item 6 forward **Electric to the Green** – The communications received from SSE and Northern Powergrid as confusing as we were told originally the electricy would be free, we need confirmation as to why we now have to pay a standing charge. Cllr Ferris will liaise with SSE and Northern Powergrid to clarify the position.

A member of the public (MOP) asked if the Footbridge between Alne and Tollerton will be open soon and would photographs be taken and a meeting with Alne PC and Tollerton PC? Cllr Taylor advised there has been an issue with the waterlogging of the land but it the bridge is nearly ready to open.

A MOP advised that on "Love Lane" rubble has been used to fill in the wholes can some gravel be placed in the holes?
